- Grooming
  - a. Work bee
    - i. All the south side is all bare Travis cleared the track
    - ii. April 30<sup>th</sup> work bee @ 9 o'clock
      - 1. Open Track for May 1st
    - iii. Suggestion to vote on going to County for Herbicide. Herbicide doesn't kill the grass, but the country has a trailer that you could rent out to tow behind the quad. But it can be expensive.
      - Better to do later we could just shut the track down for a day extra to do weed maintenance
    - iv. Gate needs to be fixed Lock has been purchased needs to be welded on.
  - b. Removal of Enduro Track to increase parking
    - i. Cassy motions we remove the Enduro track to increase parking and give the stuff from the track to Holly. Morgan Seconds
  - c. Tree Removal on the South Side
    - i. Originally there was a proposal for a pipeline, to run through the south side. Devin is going through the steps to figure out who owns the land. Waste authority owns the land.
      - 1. Remove Trees and flatten it out in behind the old endure track. 30-40 meters of trees to removal, put a fence up.
      - 2. Who gets the trees? Have to talk to Weyerhaeuser
  - d. Repairs to water truck
    - i. PTO Worst case full replacement is \$2000 no labor. He can just repair the gears with a grinder.
    - ii. Passenger side valve is stuck open \$250
    - iii. Devin motions \$2500 to pay for the Water Truck repairs. Susan seconds.
