PROMOTER CONTRACT



Thank you for hosting a race in 2023. Below is a list of requirements that are to be met for eligibility to have an Event with AMSA Offroad. An information package will follow; please make sure to familiarize yourself with everything provided. If you have any questions or concerns, please contact Race Director Stephen Foord. (403) 630-6359 Foordy15@hotmail.com

- Promoters must be in good standing with the association to be considered for an event.
- Race submissions must be received by the Race Director by November 30th yearly. Deposits must be sent to the Treasurer at amsaoffroad@gmail.com , along with this signed contract to be eligible for the calendar.
- 3. \$500 deposit All promoters must pay a deposit to have their race added to the calendar. This is to ensure that promoters are committed to the calendar and to the people racing the series. AMSA offroad is accountable to pay the insurance policy in advance of the season based on the number of events submitted. This deposit will be credited to the event insurance and in the case of weather or OHV bans a refund will be issued. (OCT.21, 2017 AGM Motion: Keith Routley . 2nd Dave French)
- Races must be cancelled by 12pm Thursday at the very latest if:
 - a) there has been a significant accumulation of rain and the ground is saturated during the week previous and leading up to the Thursday beforehand at 12pm when the call is to be made.
 - b) if the forecasted weather for race day is extreme
- Financial Aid will be provided for promoters with cancelations/postponements due to weather
 cancellations or fire bans. The aid is limited to \$1500 for the essential requirements of hosting
 an event (First Aid, Toilets, Insurance, scoring fees etc.) Receipts must be submitted and will be
 evaluated on a case per case basis. (as per April 22, 2021 minutes)
- A dedicated promoter meeting will be mandatory. (As per Dec.1 minutes)

2023 Fees are as follows:

Full License \$70
Family License \$200
Day License \$30
Prepaid Race Entry* \$50/\$35
Race Day Entry \$60/\$40 (as per 2018 AGM)

*AMSA Offroad will be handling all Pre-Entries for Championship rounds

PROMOTER OBLIGATIONS:

- AMSA will collect a \$5 rider levy per entry and it will be used to purchase rider prizes for top 5 in each class at the
 year end awards.
- 2. A mandatory \$500 Pro Payout is required.
- 3. Event Insurance will be invoiced. Note, the certificate of insurance will be provided after payment has been received.
- 4. AMSA Offroad provides a Race Office Manager. They will be providing a race day promoter package which includes: Race Entry Forms, Helmet Stickers, PA System, First Aid kits for sweepers, IN REACH (for sweepers to use), Sound Testing Equipment and log book, the Series Podium Banner, and series sponsor prizes, as well as selling licenses at sign-in. Promoters are responsible to cover the cost of 2 nights accommodation fees (Camping or Hotel) if required. Out of respect for work schedules and travel time, any additional time needed for early registration must be agreed upon by the Race Office Manager before posted to the public.
- Promoters need to provide enough volunteers to conduct race entry, race logistics, awards etc. Promoters are responsible for tracking their own site entry fees, scoring costs, and Pro payout however they choose. AMSA will manage the mototally race pre-entry.
- Promoters are required to submit an Emergency Response Plan to AMSA, and need to have a means of egress for injured riders. This must be submitted to AMSA at minimum two weeks prior to the event.
- Promoters must have a dedicated Mobile Professional First Aid Service on site with their own liability insurance and equipment.
- 8. Promoters must ensure there are a minimum of 2 proper portable public toilets on site.
- Promoters are responsible to apply for the Headlight and Tail light exemptions as per the Alberta Traffic Safety Act
 Off-Highway Vehicle Regulation.
- 10. AMSA series Sponsors must have recognition at each event.
- In the event of a protest or unforeseen issue AMSA has a Competition Committee in place to resolve any issues.
 Brody Bley is the Chair, along with Kristen Broderick, Brett Fazzio, Suzanne Pelletier, Josh Boland, and Marco Cussigh.
- Promoters will be held accountable for the complete clean up of race locations and removing arrows and ribbon from the course.
- 13. Promoter infractions will be enforced by a fine as per Rule Book 1.8.2 conduct for clubs/promoters

CENTRAL ALBERTA MOTOCROSS SERIES

The Central Alberta Motocross Series was established in 2020 we are a non-profit organization that puts on races at facilities such as yours. Our goal for the 2023 season we are looking for new tracks to join our series and are hoping to have an event at your facility. Our AGM will be held on Nov 5, 2022 at 7PM in Red Deer at Mundo Industries #3 McKenzie Drive (located next to Volkswagen just off Gasoline Alley). The meeting will be an in person meeting (bring your own chair) we are currently working on an electronic link for the meeting as well for those not able to attend.

A little bit about us- When we started in 2020 we were aiming for grass roots, family friendly race environment. We have kept the dream alive and that's exactly what we are today. Although we have grown in size faster than we ever thought our 2022 season was our best one yet averaging 300 entries per race. We have a class for every one of every age and skill level making this is a fun for the whole family series with no sanction behind it just a great group of volunteers. With having no sanction behind our club we don't have any extra fees our upcoming membership costs are \$40 a year per rider. In addition to each event held we take care of the following. Our parent run Stacyc race is done at intermission on the peewee track that we do not charge for but they will receive trophies and season points for all classes will be tallied for year-end awards for our future MX riders.

We supply trophies for each event if there is no sponsor found for trophies there is a \$900 trophy fee for each track. To help keep the costs down we are willing to help find a sponsor if the facility is unable to.

We have 2 options available for you to join us in the 2023 season.

Option 1

Your facility supplies a fully prepped track- groomed watered and race ready. Your organization is responsible for finding flaggers for the jumps, suppling medics and track staff for the day. We supply race day insurance, lap scorers and a scorer on the computer; we also supply a race day official. Entry fees are \$35 a class and we take \$5/ entry rider levy. You keep \$30 an entry and all gate admission and camping fees but no day pass will be charged.

Option 2

We make a donation to your organization in return we get a prepped race ready track (watered and groomed also watered at intermission) and we look after everything else including track staff, flaggers, gate entry and camping. If this option is chosen we will keep all profits from the event after the donation is made.

In the 2023 season our goal is to hold 6-8 rounds at 6-8 different facilities. Thank you for taking the time to consider our offer we hope to hear from you soon! Please let us know if there's any interest in joining us in 2023 we would be happy to chat and answer any questions you may have before the AGM, if you are interested please join us at the AGM or send us an email with proposed dates. We are planning to have a schedule released by end of November as so many of our families plan their summers and their holidays around this schedule.
